2. San Francisco Zoo Administrative Report (Discussion)

Tanya Peterson, Executive Director and President, SFZS Director Peterson reported attendance for November was 45,680 versus budget of 41,000 and is over budget by 4,680 visitors. Total attendance is 364,991 which is over budget by 12,691 visitors. San Francisco Zoo has joined other zoos in presenting a holiday lights shows. San Francisco Zoo Lights is a magical light show created within the unique backdrop of the Zoo. On each scheduled evening from 4:00 to 8:00, visitors will follow the path lined with twinkling animal topiaries and displays of glistening garlanded trees. The Lion House, Penguin Pool, and Primate Discovery Center also will be available. Entertainment will occur each evening. This evening is a members-only event, and the general public can view Zoo Lights on December 22, 23, 26, 27, 28, 29 and 30. Thanks to P, G &E for underwriting this event. The Connie and Bob Lurie Education Center recently was the site of the first "mini" conference for the Bay Area Chapter of the American Association of Zoo Keepers. SFZS animal keepers Helen Horblit, David Carroll, Anthony Brown, Hilary Maag and Patrick Schlemmer presented a variety of topics to a group of 50 animal care professionals from as far away as the Monterey Bay Aquarium to Safari West. In addition to the presentations, early arrivals went on an Aye-aye Forest tour, and the conference ended with an incredibly special goliath tarantula feeding by Patrick Schlemmer. On December 7th, the Zoo was able to help fulfill the wish of Make-A-Wish child Matthew Tennant. Matthew - who has stage 4 Neuroblastoma - wished to ride all of the trolleys and trains in San Francisco, We arranged for a special meet and greet with Johnny, the Little Puffer Engineer, a tour of the Little Puffer Barn, unlimited rides for the day and lunch at Lemur Café. Matthew was all smiles when Johnny brought Little Puffer around the tracks into the depot, and grinned from ear to ear as he and his mom boarded the train. Matthew's parents are so thankful that Matthew's cancer is in remission at the moment so they could make the trip here and provide this unforgettable San Francisco Zoo for their son. Our Conservation Lecture Series has two lectures scheduled in January. The first on January 17, Miles Woodruff, Jane Goodall Institute Congo Project Manager, will report on the Tchimpounga Chimpanzee Rehabilitation Center and the Mandrill Release Project. On January 26 at noon in the Great Hall of the Education Center, Carol Preston, Education and Outreach Coordinator for NOAA's Gulf of the Farallones National Marine Sanctuary, will be speaking about climate change and how it impacts the California Coast. The lectures are free and the public is encouraged to attend. Director Peterson ended her report by showing the "Jingle Penguins" video.

Committee Advisor Spinelli asked if the Fishing cat listed in Dispositions was the same as the birth listed in Acquisitions. Bocian stated it was. SFZ Board member Beech questioned the Greater kudu's birth and death. Bocian stated that both the mother and the calf died due to positioning issues with the calf. A second calf born to another mother is alive. Member of Public, Tony Colonese, asked if there had been any other instances needing to attempt repositioning of an animal. Bocian responded that he personally had no experience of this and it is an unusual event. Both SFZ veterinarians were present and in attendance; one working with the calf and the other with the mother. Member of Public, Mark Ennis, questioned if in the case of the death of the Fishing cat, the mother could have eaten the kitten. Bocian answered a camera was monitoring the nesting box and there was an indication of a kitten but after five days no sounds of a second animal were heard. The mother was shifted and there was no sign of the kitten. Ennis: Is this common? Bocian: It is something that could occur in the wild and is not unheard of. Do not know if the mother killed the kitten but if the kitten died it is something the mother could do. Being a prey animal it would not want predators to know where it is and therefore would eat the dead animal.
