### 4. Capital/Planning Monthly Update

Stacy Bradley, Deputy Director of Capital Planning, reported on

- a. South Park – opening later this month
- b. Mansell – opened last weekend, and was a big event, despite the rain
- c. Second community meeting of McLaren visioning process was also last weekend
- d. Upcoming ground-breakings: Geneva Avenue Community Garden, McLaren Bike Skills in the next month, and The Civic Center Playground on Valentine's Day
- e. Janice will be presenting the possible acquisitions in the equity zone later tonight
- f. The Natural Resources Management Plan is appealed to the Board and it will be heard on February 28<sup>th</sup>
- g. We will be presenting the Department's ten-year capital plan to the Capital Planning Committee, with the bond now being in 2019. There will be a 2018 seawall bond for the Port.

Kenneth Maley, District 3, announced that the Friends of Washington Square has been lobbying the PUC and Rec and Park for new infrastructure and water conservation at Washington Square for the past several years. It has not had major infrastructure improvements since the first master plan of 1957. He hopes that he and the Friends of Washington Square can play a similar role in interfacing with the Department and contractors. He also wanted to make the Committee aware of, and to extend an
