### 4. Capital/Planning Monthly Update: Discussion Only

Stacy Bradley, Deputy Director of Capital Planning, reported:

- a. McLaren Bike Park is moving forward on adding a new bike skills park to McLaren
- b. Moscone Rec Center – Playground is getting improved with a bike space for young children to learn how to bike. There is also a potential dog play area.
- c. Francisco Park – We have reached an agreement with our partners and we are going to be going through the approval process this month. It will be an agreement to accept them and the agreement with the conservancy on how to operate and maintain the park together. The agreement is for 25 years, with 10 year extensions up to 50 years.
- d. Hilltop – new skate park, barbecue area, picnic area, exercise space for adults and a lot of sustainable features with native and drought resistant plants. It is in construction now and will open later this year, with funding from TKL Partnership, Parks 94124, COF from the 2012 Bond.
- e. D6 Acquisition – Stacy will have a full update regarding 11<sup>th</sup> and Natoma/Minna in July. It's a 20,000 sq.ft. property for \$10 million. The last lease with options goes until 2024.
