Agenda Item Wording: Discussion and possible action to award a construction contract to construct base bid items for the renovation of Hayes Valley Playground and Clubhouse, contingent on the Human Rights Commission certification, to either:

1. Fineline Construction in the amount of \$2,100,000, or
2. Roebuck Construction in the amount of \$2,106,500, or
3. KCK Builders in the amount of \$2,169,000

Background:

Hayes Valley Playground, located at the corner of Hayes and Buchanan Streets in the Hayes Valley neighborhood, consists of a play area, clubhouse and sport courts. In 2008, the Recreation and Park Commission approved a conceptual plan to renovate the play area and clubhouse at Hayes Valley Playground. The Recreation and Park Commission also recommended that the Board of Supervisors accept a gift valued up to \$1,500,000 from Trust For Public Land (TPL). The City budgeted \$1,918,050 toward project construction. The gift from TPL will cover the amount in excess of the City's budget toward project construction.

The Recreation and Park Department advertised a bid package for competitive bids. The bid package included base bid items plus a deductive alternate (eliminate living roof) in case base bid costs exceeded the budget. Seven bids were received that ranged from \$1,990,000 to \$2,650,000 for base bid items. The average bid is \$2,178,214, which is comparable to the engineer's estimate at \$2,215,700.

Although Rodan Builders and BHM Construction submitted the lowest base bids, when HRC discount points are applied the apparent lower bidders were determined to be Fineline Construction, Roebuck Construction and KCK Builders. (See Attachment A) Bid protests were received against Fineline Construction and Roebuck Construction at the time of this staff report to the Commission. The lowest responsive and responsible bidder will be determined through review by the Human Rights Commission and presented at the Recreation and Park Commission hearing.
