Online tee time reservations can be made by visiting www.sfrecpark.org/golf. To book the resident rate online, please log in with your initial username and password, which was provided by letter. **Note*: You may change your username and/or password at any time after initial login by selecting the "Manage Your Account" icon.*

Note: The telephone reservation system (415750GOLF) was discontinued on March 28, 2016.

RESIDENT GOLF CARD PROCEDURES

There are **THREE (3) OPTIONS** for Resident Golf Card registration and renewal.

OPTION 1: TPC HARDING PARK GOLF SHOP – New resident golf cards and golf card renewals may be obtained at the TPC Harding Park Golf Shop. You must bring the required paperwork with you. To register or renew your Resident Golf Card, please visit the TPC Harding Park Golf Shop at the following dates and times:

- **Monday – Thursday: 10am – 4pm**
- **Friday – Sunday : 11am – 4pm**

OPTION 2: ONLINE – You can obtain a new resident card or renew your current card online by uploading your information and submitting it to our office. We will then contact you by phone or email to complete the process. [CLICK HERE FOR ONLINE SERVICE](#). OPTION 3: ANNEX BUILDING AT McLAREN LODGE – For residents who are unable to visit TPC Harding Park or access the internet, services will be available at the Annex Building at McLaren Lodge, 501 Stanyan Street **by appointment only**. To schedule an appointment, please call (415) 831-2771 or email residentgolfcard@sfgov.org. You must bring the required paperwork with you. Checks, cash or credit cards (Visa, Mastercard or Discover) are accepted.

HOW TO QUALIFY FOR A RESIDENT CARD – REQUIRED DOCUMENTATION

To qualify as a San Francisco or Pacifica resident, applicants must provide the following documents:

1. **Government-issued Photo ID:** For example: Valid California State Driver’s License (“CDL”), California State Identification Card (“CID”), or other government-issued photo ID (ex: passport) – AND;
2. **Proof of Residency:** You must also provide supporting documents evidencing proof of residency no older than 90 days. Examples include:
 - Utility Bill (must have your name on it)
 - Property Tax Statement (must have your full legal name on it)
 - Bank Account Statement (must have your name on it)
 - Other type of recurring commercial bill received within the past 90 days (must have your name on it)

NOTE: If the above Government Issued Photo ID and Proof of Residency list the same address you are done.

However, if you are supplying a Government-issued Photo ID with an address that does not match your proof of residency or if you are supplying a government-issued Photo ID that does not list an address (i.e. passport) – you must submit two (2) Proof of Residency documents as described in item #2 above. The two (2) Proof of Residency documents must have the same address.

PACIFICA RESIDENTS – To qualify as a Pacifica resident, applicants must present the same required documentation as stated above evidencing a Pacifica address. Please note Pacifica resident cards are valid for discounted golf fees at Sharp Park only.

SAN FRANCISCO PROPERTY OWNERS – If you are the legal owner of property within the City and County of San Francisco and pay taxes on that property, and your name is printed on the deed or the property tax receipt, you will qualify as a San Francisco Resident and may receive a card, even though you may reside outside the City limits. You will need to supply proof of ownership (i.e. current property tax receipt, date-stamped copy of deed – that includes your name) along with the applicable required government issued photo ID described above. This policy also applies to Pacifica property owners who live outside the City of Pacifica for cards to be used only at Sharp Park Golf Course.

OTHER DETAILS

1. **Cost (as of July 1, 2019):** The cost of the Resident Golf Card is one-hundred and seven dollars **(\$112.00)**. The cost of the Pacifica Resident Golf Card is seventy-one dollars **(\$74.00)**.
2. **How long will the card be valid?** 2-years from the date of issuance.
3. **Property of the San Francisco Recreation and Park Department** – Resident cards are the property of the San Francisco Recreation and Park Department. Resident cards are for the use of current residents of San Francisco and Pacifica only. Golfers may be refused playing privileges for submitting false information for the purpose of securing a resident card. Any misuse of a resident card may result in the card being revoked.
4. **Lost Cards** – Lost San Francisco Golf Resident Cards that have not expired may be replaced at a cost of **\$31.00**. The replacement card will have the same expiration date as that of the lost card. If the lost card is nearing its expiration date, the golfer may choose to renew for an additional two-year card. The expiration date of the new card will be two years from the date of issuance.
