Willie "Woo Woo" Wong Playground Determination Regarding Bid Protest

Dear Mr. Liang:

The City and County of San Francisco ("City") has completed its review of CLW Builders, Inc. ("CLW") bid protest against the bid submitted by Azul Works, Inc. ("Azul") for the Contract No. 1000008750, Willie "Woo Woo" Wong Playground project ("Project"). After considering all the information, the City has deemed Azul Works, Inc. non-responsive.

On April 17, 2018, San Francisco Public Works ("Public Works") received two (2) bids for the Project, including the bids submitted by Azul and CLW. On Monday, April 23, 2018 CLW protested Azul's bid claiming that Azul failed to meet the required 14% Local Business Enterprise ("LBE") participation goal.

Pursuant to the analysis provided by the City's Contract Monitoring Division (attached), the City finds that Azul has not met the LBE Participation Requirement. The City therefore accepts CLW's bid protest and deems Azul non-responsive.

The Contract Monitoring Division ("CMD") has reviewed the bids, the application of the appropriate discounts/bonuses, and determined responsiveness to Chapter 14B pre-award requirements. Below is a summary of CMD review:

LBE Bid Discount

Due to the dollar value of the engineer's estimate, 10% bid discount applies to any bid submitted by CMD-certified Small or Micro-LBEs.

Two bidders submitted bids as follows:

CMD deemed Azul Works, INC. non responsive because they did not meet the 14% LBE requirement. CLW Builders, INC. submitted a base bid of \$8,883,600 and met the 14% LBE subcontractor participation requirement by listing the following firms:
