3. San Francisco Zoological Society Administrative Report.

(Discussion)

Tanya Peterson, CEO & Executive Director, SFZS

Ms. Peterson provided an update on administrative affairs, reporting on visitor attendance for the month of March 2018, which was 59,942 versus a budget of 74,000 due to unforeseen rain days; however, year-to-date attendance is ahead of budget by 31,959 visitors. Ms. Peterson noted that SFZS' "Little Puffer" Steam Train had not been operating for a few months due to a longer-than-anticipated annual maintenance cycle, which impacts revenue projections. In terms of Spring education and community programming, Ms. Peterson summarized the following: (1) 3rd Annual "Bay Area Teen Science" event at SF Zoo; (2) 12th annual "Wild About Art & Science" program; (3) "National Volunteer Week" celebrations; (4) April Earth Day celebrations to include the opening of a migratory species garden made possible by SFZS Emeritus Board member and Docent Gail Secchia; (5) SFZS Docent and Master Birder Allan Ridley's Spring Bird Walk in April; (6) first-ever "Meatless Cook-off" hosted at SF Zoo; and (7) a free lecture on shark conservation. Lastly, Ms. Peterson thanked all for their support of SFZS' upcoming annual fundraiser, *ZooFest 2018*, which honors Emeritus Board member Barry Lipman and his wife, Marie.

Vice President of Animal Care and Enrichment, David Bocian, provided a presentation on SFZS' accrediting body, the Association of Zoos & Aquariums (AZA). In addition to accreditation, AZA provides educational opportunities via conferences as well hosts scientific committees to address conservation and other concerns. For example, Mr. Bocian discussed AZA's Species Survival Programs (SSP) to ensure genetic diversity in species and AZA's "Saving Animals from Extinction" (SAFE), whose programs focus on critically endangered species, including SFZS' Western Pond Turtle project. Lastly, Mr. Bocian also discussed zoological trips to the wilds, including his recent trip to Ecuador to learn more about Andean condors in the wild in an effort to design better Zoo exhibits.
