**3. San Francisco Zoological Society Administrative Report.**

**Tanya Peterson, CEO & Executive Director, SFZS**

Ms. Peterson provided an update on administrative affairs, reporting on visitor attendance, with year-to-date attendance ahead of budget by 9,586 visitors. Ms. Peterson announced that world famous gorilla “Koko” had passed away. Koko was born at the San Francisco Zoo before she moved to the nearby Gorilla Foundation. Ms. Peterson discussed the recent “Coffee with the CEO” Members’ Morning event that she hosted in the Leaping Lemur Café. She then discussed the juvenile mandrill birth and its integration into the troop; she announced that snow leopards “Jimmy G” and “Dawa” were new parents after the birth of twin cubs. She reported that SF Zoo’s Insect Zoo staff participated in the annual San Francisco butterfly count, counting a record number of butterflies in the area. Ms. Peterson discussed current summer programming taking place at the Zoo, including the Nature Trail, Talk on the Wild Side and Wildlife Theater programs. Ms. Peterson reported that three penguin chicks had hatched but currently are off-exhibit as they learn to be hand-fed by Zoo staff. The three penguin chicks will join the older penguins on Penguin Island on July 28, as part of SF Zoo’s annual “March of the Penguins” event. She announced that the Zoo would be celebrating World Giraffe Day all weekend on June 23 – 24 to highlight giraffe conservation. Lastly, Ms. Peterson thanked outgoing Joint Zoo Committee member Dexter Lowry for his years of dedication to the Committee.
